#### A. Financial

- For 5th year in a row, the Council has been able to maintain services with no tax increases acknowledging ongoing fiscal constraints in RI.
- Community Center: new roof; generator (for respite during extreme weather conditions) in addition there were new lighting fixtures installed (interior and exterior) per code and safety issues
- Patriot Disposal Service was chosen to manage the District's waste disposal at a small annual increase for the service.

## B. Little Beach/Kelly Beach:

- Two lifeguard chairs were added to Kelly Beach

## Bonnet Shores Fire District Annual Meeting June 27, 2013

## Treasurer's Report Fiscal Year Ending April 30, 2013

**Total Revenue: \$271, 633** 

Tax Revenue represents 91% of total revenue; hall rental fees, newsletter advertising represent other income.

Total Expense: \$231,049

Sanitation totaled \$108,600; or 47% of total expense; beach expenses were \$31,731 or 14% of the total.

#### **Capital Budget:**

\$21,082 was spent on Capital Improvements, such as lease payments on the Backhoe and mooring replacements at the Little Beach; about \$9,600 was appropriated to the Capital Budget, which help towards replacing the roof at the Community Center during this fiscal year. We ended the year with a surplus of about \$9,600.

As reflected in the Spring Newsletter, General and Operating Fund Balances at fiscal yearend totaled more than \$54,000 and the Designated Fund Balance was more than \$78,000—of these the Capital Fund Account was the largest at \$32,464 and Harbor Improvement at \$17,729.

A 4.1% tax increase was approved for the fiscal year 2013-2014—in great part due to the increase in sanitation. The approved budget is available in the spring newsletter.
