**Treasurer's Report
Fiscal Year Ending April 30, 2014**

Total Revenue: \$272,634

Tax Revenue represents 93% of total revenue; hall rental fees, newsletter advertising represent other income.

Total Expense: \$249,956

Sanitation totaled \$129,197 or 51.69% of total expense; beach expenses were \$32,992 or 13.2% of the total.

Capital Budget:

\$34,837 was spent on Capital Improvements, such as lease payments on the Backhoe and mooring replacements at the Little Beach; and the new roof at the Community Center.

We ended the year with a surplus of about \$22,700

As reflected in the Spring Newsletter, General and Operating Fund Balances at fiscal yearend totaled more than \$53,000 and the Designated Fund Balance was more than \$70,000.

There are three items on the current Capital Improvement Budget: the final payment on the John Deere backhoe, \$6,000 for mooring replacements at Little Beach; and \$2,000 for a storage shed at the Community Center.

There is no tax increase proposed for the current fiscal year. The approved budget is available in the spring newsletter.
