Bill and I met with URI School of Oceanography on Monday to discuss the issue of sand and seaweed at Little Beach. It was an enlightening discussion. John King and his associate Carol, reviewed the beach coast line from 1887 to 2014. They determined direction of sand movement, talked about sea level rise and also why seaweed is trapped. They also review the pond and the benefit of taking sand out. We are hoping that in the spring they will make a presentation to council outlining some of the issues we covered.
