Per the Legal Services contract between the Bonnet Shores Fire District and Conley Law and Associates, I have determined that the Firm must discontinue its services at this time. By way of explanation, the Firm was engaged to provide legal advice and counsel to the Bonnet Shores Fire District regarding the Proposed Amendments to the Fire District Charter. As you know, the Firm worked closely with the Bonnet Shores Fire District Charter Committee to assist in drafting the Charter Amendments, which the Bonnet Shores Fire District Charter Committee adopted. To that extent, The Firm has completed the Legal Services for which it was engaged.

It has also come to my attention through communications with Carolyn DiLeo, Chair of the Bonnet Shores Fire District Charter Committee that there is a conflict between the Bonnet Shores Fire District Commission and the Bonnet Shores Fire District Charter Committee regarding the Amendments approved by the Charter Committee. Given a conflict regarding the Amendments between the Fire District Commission and the Fire District Charter Committee, this Firm may not provide advice and counsel regarding the conflict matters. Therefore, please accept this correspondence as termination of the Legal Services contract.
